INVITATION FOR PREQUALIFICATION AND TENDER FOR PROPOSED 2024 TERTIARY EDUCATION TRUST FUND (TETFUND ANNUAL) INTERVENTION FOR ICT SUPPORT.

2. ELIGIBILITY REQUIREMENTS

The University invites interested contractors to submit the following documents:

- a. Evidence of Certificate of Incorporation issued by the Corporate Affairs Commission (CAC) including Forms CAC 2 and CAC 7;
- b. Evidence of Company's Income Tax Clearance Certificate for the last three (3) years: 2022, 2023, 2024 valid till 31st December, 2025.
- c. Evidence of current Pension Compliance Certificate valid till 31st December, 2025;
- d. Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2025;
- e. Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2025;
- f. Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers, by submission of Interim Registration Report (IRR) expiring on 31st December, 2025 or valid Certificate issued by BPP;
- g. Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal University Wukari or the Bureau of Public Procurement is a former or present Director, shareholder or

has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.

- h. Company's Audited Accounts for the last three (3) years, 2022, 2023, 2024.
- i. Evidence of financial capability to execute the project including
- j. Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (In case of construction: COREN, QSRBN, ARCON, CORBON etc).
- k. Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Award, Valuation Certificates, Job Completion Certificates
- l. All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized Officer of the firm.
- m. Evidence of NITDA Clearance Certificate.
- n. Evidence of CPN (Computer Professional of Nigerian).

3. COLLECTION OF TENDER DOCUMENTS

Interested companies are to collect the Request for Quotations (RFQ) from the office of the Director of Procurement, Federal University Wukari, K/m 200 Katsina-Ala Road, P.M.B 1020 Wukari, Taraba State.

4. SUBMISSION OF TENDER DOCUMENTS

Prospective bidders are to submit their Quotations in sealed envelopes addressed to: The Head, Procurement Unit, Federal University Wukari K/m 200, Katsina –Ala Road PMB 1020 Wukari Taraba State and clearly marked with the name of the project and the LOT number.

5. OPENING OF QUOTATIONS

The Quotations shall be opened immediately after the deadline for submission as Stipulated in the Procurement Office, Federal University Wukari, Taraba State in the presence of the bidders or their representatives.

6. GENERAL INFORMATION

- a. Bids must be in English Language and signed by an official authorized by the bidder;
- b. Bids submitted after the deadline for submission would be returned un-opened;
- c. Bidders should not bid for more than two (2) Lots
- d. All costs will be borne by the bidders;
- e. Only pre-qualified bidders will be invited at a later date for financial bid opening, while financial bids of un-successful bidders will be returned un-opened;
- f. The Federal University Wukari Taraba State is not bound to pre-qualify any bidder and reserves the right to annul the Procurement process at any time without incurring any liabilities in accordance with Section 28 of the Public Procurement Act 2007.
